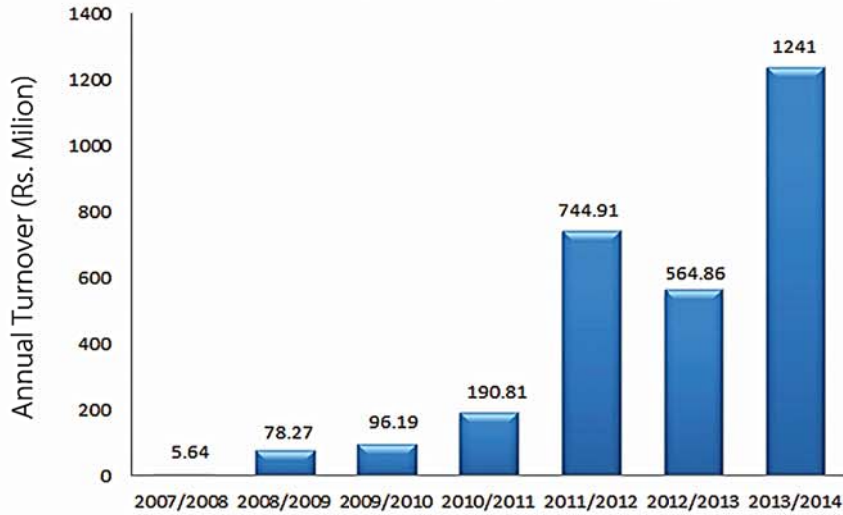

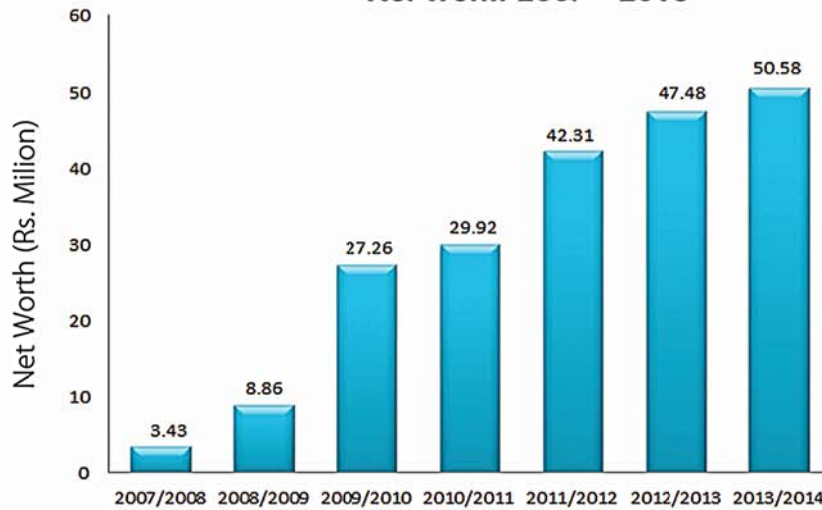

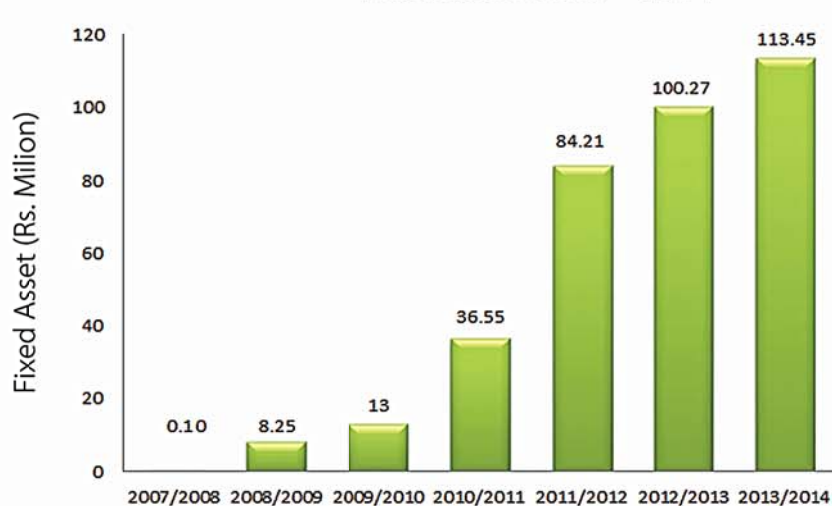
Turnover 2007 - 2014



Net Worth 2007 - 2013

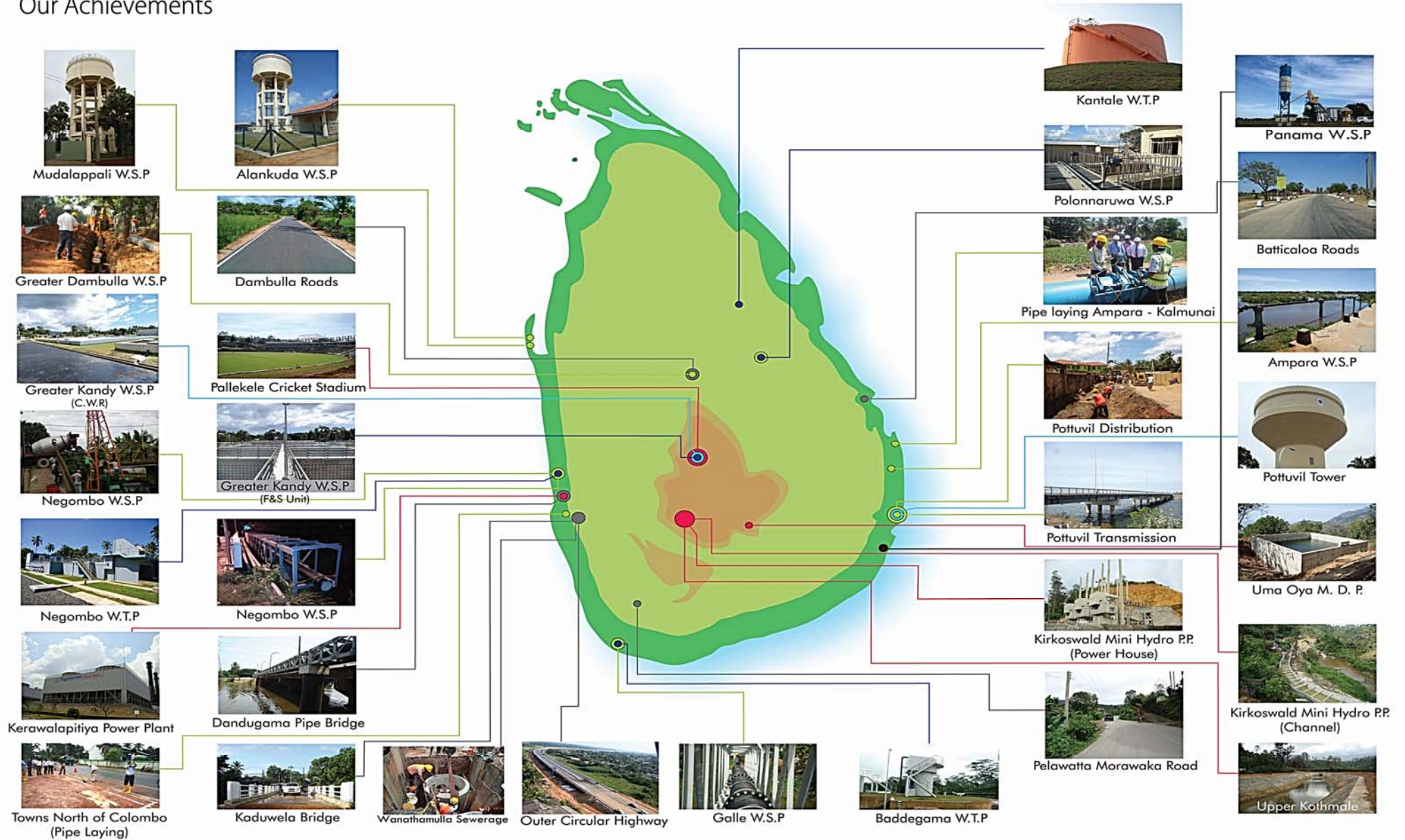


Fixed Asset 2007 - 2014

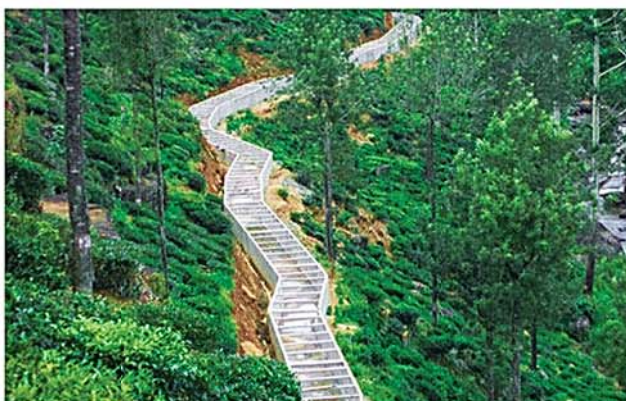
